**Review of Investments with NEPC:** Mr. Driscoll provided a market update as of April 30, 2023, and reviewed our funds results for that timeframe. Reviewed all our asset classes, focused on the real estate markets and the issues with office space no longer being required for companies in many cities. Reviewed his outlook on the market and how we can best position ourselves.

**Board Counsel Report:** Mr. Quirk reported on the issues that are currently being experienced with CRAB and the fact that they have hired additional magistrates. Mr. Gibson discussed a recent case that would make any payments for temporarily holding a higher job class (i.e., a firefighter being asked to be the interim chief) be non-pensionable.

Report of the Executive Director: Mr. Soohoo provided the Board members with the finalized annual statement for them to sign as it has been submitted to PERACO through PROSPER. Mr. Soohoo informed the board the retroactive COLA increase of 2% has been paid in the May pension payroll. The office will send out the appropriation letters to the town this week. Mr. Soohoo also discussed issues with the disbursement and payroll checks as they are signed by the previous Treasurer and will need updated signatures in the future.

The Board reviewed the Budget through April 2023.

**Update of cash books:** Mr. Soohoo advised that January through March are almost complete and will be submitted by the next board meeting.
